

Central District Athletic Board
Minutes: June 2, 2010

The Central District Athletic Board of the Ohio High School Athletic Association met in regular session on June 2, 2010 at the LaScala Restaurant, Dublin for the purpose of conducting business, receiving reports, and reviewing tournament evaluation with tournament managers.

Minutes

Galen Kyre, Secretary, presented the minutes of May 21, 2010 for review and approval.

Manager's Reports

Swimming and Diving: Thirty eight of the 64 schools participating returned form (59.4%) No schools rated tournament operation as "Poor" Seven schools rated the tournament operation as "Fair". Todd Grant, Manager, told the Board that the meets are getting larger, thus suggesting that additional sites be found. Todd is to investigate this possibility. Lack of fan and participant seating was a factor in the evaluations. A uniform violation occurred, to be corrected next year.

Bowling: Jo Dimond, Manager, reviewed the coaches' evaluation of the tournament. The bowling tournament is expanding at a fast rate. Additional sites may be needed. Sixty one boys teams and 55 girls teams participated in the two sectional tournaments. Among the problems reported was adequate seating for fans and participants, passes for coaches and players, starting times 8:00 a.m. and 1:00 p.m. Seeding and placing schools to sites. Bowling Centers will be the same next year.

Track: Bob Mehl problems faced during the track and field tournament. Timing equipment malfunctioned and there were minor problems at Groveport. Due to these problems some officials and workers worked longer than usual. Mehl asked the Board to compensate those individuals for the extra time.
