a. Golf – Larry Morris – 3:15 p.m.

Asking Apple Valley to host more than the DI Boys tournament. Asking to host all boys' tournaments and Echo to host both Girls tournaments. There were concerns with the live scoring app from several coaches especially during the boy's tournament, 75% of the app was consistent with the score card. Would like for the OHSAA to look at an alternative scoring app. 18 teams in a division is the tipping point to warrant 2 sites for the sectional tournament. By splitting it

up it does speed up play, however you are not sending very many golfers to each course. Courses and hosts have been great at running the tournament and Mr. Morris would like to thank them for their efforts.

Bradley will not be able to be a site for DIV next year. Would like the draw meeting online, would like to return to in person meeting. Online is more convenient, however, coaches are also concerned that they do not receive the draw information. Granville concerns due to distance, but they did a good job of hosting the tournament.
