Typically, only hold two finals at a site. Last year had 5 finals sites and could be up to 9 sites this year. Survey the schools in the district to see if any schools would be willing to host due to tournament expansion. Look at alternate dates as opposed to holding all the finals on the same day ie: Thursday and Saturday. Can host different divisions at the same site. Ms. Logan will be back with the final recommendation at the June 17, summer meeting.

Mr. Hamrick handed out a planning document for suggested play dates due to the expansion to 5 divisions. Will DI and DII be treated the same as the other divisions?
