Q8: Explain how the student meets each one of the four criteria expressed in the bylaw. Use additional sheets of paper as necessary or type out responses to include as an addendum.

A. Safety risk to self or others: This item means that the student is not of the size, physical and/or developmental maturity that might predispose him or her to place others at risk or him or herself at risk if an additional year of participation were granted. Please include information about the student's physical characteristics including height and weight when addressing this issue.

B. Advantage as to physical, mental or athletic maturity: This item means that the student does not have physical, mental and athletic maturity similar to students who have achieved significant development as athletes and who have shown prowess and impact in their selected sport or sports.

C. Impact on outcome/meaningful participation: This concept refers to the notion of keeping the playing field as even as possible by preventing students who have had an additional year of experience in a sport or who have had the advantage of age and maturity from participating against students who have had neither of those advantages. A student approved under this exception would not likely participate in any meaningful way and would certainly not have an effect on the outcome of any contests in which the student did participate. The OHSAA will not grant exceptions to students whose past performance in a sport or sports has been of such a caliber that further eligibility would be unfair to the opponents of the member school the student in question attends. To this end, please provide **statistical information about the student's playing time, honors achieved, places in competition earned and letters/awards earned in each sport.**

D. Red shirting: This item means a student is not seeking to utilize this exception in a deliberate attempt to retain a student in a grade for the purpose of gaining an extra year of eligibility and thus obtaining an athletic advantage.
