# **Tournament Entry:**

If you have not already done so, please login to your high school's myOHSAA account and set the tournament entry to properly reflect your school's current intentions regarding the OHSAA Tournaments. **NOTE:** The golf and girls tennis tournaments are quickly approaching, so please review the tournament entry for golf and girls tennis today.

Further, if your school has girls that participate on the boys' team in an OHSAA individual sport, please follow <u>this link</u> to read more and ensure you understand the tournament entry process for these student-athletes to avoid penalties.

# View State Meeting Attendance:

Please be sure to check that your coaches have completed their state rules meetings by using the 'View State Meeting Attendance' link. Attendance is required to participate in the OHSAA tournament for that sport.

Remember, credit for a state rules meeting is given to the person completing the meeting. Credit is then transferred to the school **if that person is successfully listed in the 'Staff Management'** portion of the school's myOHSAA account.
