NEW! Current List of 2025 Referendum Issues Available

The OHSAA Board of Directors has currently approved recommendations from the Executive Director's Office to place nine items (one Constitution, eight Bylaws) up for referendum vote of the membership for 2025. Member school principals will vote upon these issues between May 1 and 15. A few additional referendum items to place before the membership may be approved by the Board in March. NEW! 2025 Athletic Discussion Meeting Sites and Dates Set

The 2025 OHSAA Athletic Discussion Meetings have been finalized with the dates and locations for the six meetings listed below. OHSAA Director of Compliance Kristin Ronai will review the 2025 referendum issues and Executive Director Doug Ute will discuss a few topics of current interest to administrators involved with or interested in the school's interscholastic athletics program. Meetings will last approximately two hours, and there is no cost to attend. The meetings are intended for superintendents, high school principals, high school athletic administrators, 7th-8th grade principals and city supervisors. Attendance by at least one school administrator is highly encouraged. **School administrators are asked to coordinate their registration efforts through the high school athletic administrator.** He/she was emailed a link to register on-line. NEW! OHSAA Board Approves Recommendation to Change Start Date for May Activities

At its regularly scheduled meeting on February 20, 2025, the OHSAA Board of Directors approved a recommendation from the Executive Director's Office that slightly modifies some May dates surrounding activities in team sports. Coaching and/or instruction by the school's coaching staff in the team sports of baseball, basketball, field hockey, football, ice hockey, lacrosse, soccer, softball and volleyball for any number of students from their teams in excess of the limit set forth in General Sports Regulation 7.3 for a maximum of 13 days has been permissible from May 15 through July 31 (General Sports Regulation 7.5.1, 13-Day Rule). **The Board-approved modification moves the start date for the 13-day coaching period to begin on the Monday of that mid-May week, which in 2025 is May 12.**

Additionally, modifying the start date in General Sports Regulation 7.5.1, 13-Day Rule, would also mean other OHSAA General Sports Regulations would need modified as follows:

- 1.) 7.3.1, Note a.) — The team limit would not be in effect for the sports of basketball, field hockey, football, ice hockey, lacrosse, soccer and volleyball from **May 12 (2025) to July 31** when a non-interscholastic team is coached by a coach not employed by the school in which the team members are participating.
- 2.) 7.10.1, Individual Skill/Coaching Instruction — From **August 1 through May 11 (2025)** in the sports of baseball, basketball, field hockey, football, ice hockey, lacrosse, soccer, softball and volleyball, individual skill/coaching instruction may be received by a member of an interscholastic team or individuals at any time prior to and after the school season and outside the defined no-contact periods from school coaches provided the number of individuals per group per school coach providing instruction does not exceed the team limit set forth in General Sports Regulation 7.3.
- 3.) 7.10.2, Individual Skill/Coaching Instruction — From **May 12 (2025) through July 31** in the sports of baseball, basketball, field

hockey, football, ice hockey, lacrosse, soccer, softball and volleyball, individual skill/coaching instruction may be received by a member of an interscholastic team or individuals at any time from school coaches provided the number of individuals per group per school coach providing instruction does not exceed the team limit set forth in General Sports Regulation 7.3.

NEW! OHSAA Board Approves Recommendation to Change 2025-26 Start Dates in Golf and Wrestling

At its regularly scheduled meeting on February 20, 2025, the OHSAA Board of Directors approved a recommendation from the Executive Director's Office to modify the start dates for coaching and contests in golf and wrestling for the 2025-26 school year as follows:

- Golf coaching and tryouts and the start of the season for competition will be the last Monday in July for the foreseeable future, which will be July 28 in 2025.
- With Christmas Day and New Year's Day on Thursdays in 2025, wrestling coaching and tryouts will be Friday, November 14, 2025, and the start of the season for competition will be Thursday, December 4, 2025.

NEW! Basketball Out-of-Season Reminders

School coaches are permitted to coach non-school teams (AAU, AYBT, GYB, etc.) outside the season with players from your school teams on it. Before they coach and have voluntary practice outside the season, read these regulations that must be followed:

- 1.) The No-Contact Period must be followed. It still exists and means that your school coach will NOT be permitted to coach starting with the first day after the school's last interscholastic contest and ending 28 days later. This means that no coach, paid or volunteer and approved by the Board of Education, shall coach or provide skill instruction to team members in the sport of basketball during this no-contact period. This includes any type of tryouts in or out of school for purposes of non-interscholastic competition. A second No-Contact Period for basketball exists each year from August 1-31.
- 2.) General Sports Regulation 7-3-1 indicates the number of team members that can participate together on a non-interscholastic team. In place since August 1, 2022, a non-interscholastic team may now have three (3) players that played for the same school team. Whether a school coach or a non-school coach is coaching a non-school team, only three players from the same school team are permitted.
- 3.) There can be no rotating players from your school teams from one non-school game to another. In other words, a team that consists of three players from your school does NOT mean that non-school team can use three different players in each game in which it plays or cannot move players in and out of that same non-school team from one weekend to the next. This is true whether or not the school coach is coaching the non-school team.

First Contest – Friday, March 28
Non-Interscholastic Deadline Date – Monday, April 7

Boys Lacrosse and Girls Lacrosse

Coaching, tryouts and Instruction – Began Monday, Feb. 17
Scrimmages with Other Schools – 3 after practice begins
First Contest – Friday, March 21
Non-Interscholastic Deadline Date – Monday, March 31

Softball

Coaching, tryouts and Instruction – Began Monday, Feb. 17
Scrimmages with Other Schools – 4 after practice begins (or 3 scrimmages and 1 preview)
First Contest – Saturday, March 22
Non-Interscholastic Deadline Date – Saturday, March 22

Boys Tennis

Coaching, tryouts and Instruction – Begins Monday, March 10
Scrimmages with Other Schools – 1 after practice begins but before first contest
First Contest – Friday, March 28
Non-Interscholastic Deadline Date – Monday, April 14

Coaching, tryouts and Instruction – Began Monday, Feb. 24
Scrimmages with Other Schools – none permitted
First Contest – Saturday, March 29
Non-Interscholastic Deadline Date – Monday, May 5

Coaching, tryouts and Instruction – Began Monday, Feb. 24
Scrimmages and/or Previews with Other Schools – 6 after practice begins
First Contest – Friday, March 14
Non-Interscholastic Deadline Date – Monday, March 31

About Coach Beyond: In 2021, the OHSAA and LiFesports at The Ohio State University started collaborative work to change the landscape of coach training and education in Ohio. Ultimately, this partnership grew into a statewide initiative known as Coach Beyond. Over the last three years, a team of coaches, athletic administrators, OHSAA administrators and LiFesports leaders set out to audit coaching education, conduct a statewide needs assessment, design and pilot trainings and ultimately train 15,000 coaches by June 2024. This goal has been reached, with 23,500-plus coaches receiving this training. Competitive Balance Roster Data Entry Period for Winter Sports

Administrators are reminded that the window to enter Competitive Balance roster data for the winter sports of boys basketball and girls basketball is currently open. Athletic administrators, or their designees, must submit their roster data within FinalForms. The deadline to submit basketball roster data is **Friday, April 4, 2025**. **ALL** schools that compete in varsity basketball contests must submit their roster data by that date.
