It was relayed to Ms. McClain that there are no plans to change in the future and that spectators can purchase tickets prior to the event online at home. Ms. McClain and Ms. White announced that they will be stepping down as tournament managers. On behalf of the board, Mr. Warner thanked them for their time and service over the years and said that they would be hard to replace.

Mr. Reidler handed out items for discussion and action which are attached. The biggest item of concern was that we had venues sell out of tickets and some spectators were not able to get into the events.
