 - a. Gymnastics Nikki Gates and Michelle Fox 3:20 p.m.
 - Overall went very well. Some of the comments about time management at the vault. Will address the morning session coaches decided to make senior awards and some coaches did not know. We will now know what the awards presentations will take place. The afternoon scores are usually higher in the afternoon than the morning. Not a lot can be done about that discrepancy. Is there a solution to seed individuals as well as teams. Several coaches wanted to adjust competing times on a different apparatus so they can be at athletes' routine, some coaches coach several teams or individuals. Feedback overall was good and will take into consideration all the remarks and suggestions. Aready have ideas for next year to make it better.

b. Swimming and Diving – Jon Reidler – 3:30 p.m.

Handed out a summary of comments from the evaluations.
