3. Financial Report (Hayes)
Shared information about ticket pricing for Fall 2023, cash box requirement for high school venues. Cash box option will lead to increase Flat Fees to provide funding for staffing needs. Hard to determine the impact new ticket prices will have on overall revenue. Decrease in student prices would have a negative impact which hopefully will be offset by the \$10 cash price option.

 - a. Jo Dimond – Bowling – In Ms. Dimond’s absence, Mr. Fitzgerald reported there will be a need to have a draw meeting for D1. Draw procedures will need to be developed. Mr. Hayes shared he will research past practice to see if he has anything on file for procedures.
 - b. Tom Stoughton – Boys and Girls Basketball – confirmed with the board he will continue to work with Ohio Dominican and Capital University to serve as District final host sites.
 - c. Tom Rooney – Wrestling – provided updates on a new length of break schedule (30 minutes instead of 45), no change in D1 sites, D2 – Jonathan Alder sectional will send District Qualifiers to the NW District, Licking Valley sectional will send

District Qualifiers to the SW District. D3 – Ridgedale is confirmed as one site. Waiting to see what the SE is going to do with respect to sending schools to the Central before he finalizes a second site. Heath will be hosting the D3 District.

- d. Michelle Fox – Gymnastics – will be meeting Marty McLain and Debbie White in the near future to discuss logistics of the District meet. Will have a complete report at the October meeting.
- e. Jon Reidler – Swimming and Diving. Provide updates – planning to use Upper Arlington and Worthington Pool for D1, Columbus Academy and Columbus School for Girls for D1. Still working on another D1 site; no response from Kenyon, Marion YMCA is a possible site but has limited spectator capacity. Reminder that Ohio State is only available for T/Th dates for Districts. Ohio University is available for F/S dates. Board supports pursuing use of Ohio University for the District for 2024. Ohio University does not have a diving well, Columbus Schools for Girls can host D2 Diving, Jefferson Country Club can host D1.
