8. Recommend approving the following changes to the CDAB Handbook, and Tournament Managers Manual:

- a. **Baseball/Basketball/Volleyball/ Soccer/ and Softball**

Passing on bracket placement for the sports of: The number of schools advancing to the regional tournament may pass. All others must place themselves on the bracket when their seed is called. Example: If five teams are advancing to the regional tournament, seeds No. 1 through No. 5 may pass, but all other teams must place themselves on the bracket. (BOD approved 9/26/25)

- b. **Tennis**

A site selection meeting will be held three days prior to placing individuals on the bracket. During the site selection meeting, the coaches will pick their sites in order of seed. Only the top 4 seeds will be allowed to pass in both Divisions I and II.

- c. **Boys Wrestling**

Placement of teams on the bracket will start with the number one seeded team and continue through the last seeded team with no bumping allowed.
