- Meeting Minutes

- Fall Tournaments
  - Golf Team Assignments
    - Board discussed the change to open draw for Girls D1 golf in the North and the confusion that surrounded
      this change and its implementation with the tournament managers. Agreed that best course of action is to
      meet with Golf Tournament Managers following the tournament season.
    - Paul/Ashley also shared that the pairings/tee sheets were sent out in the wrong order that is listed in the OHSAA tournament regulations. Phil will follow up with both managers to make sure we are following proper procedures.
  - Cross Country
    - Board reviewed the change in number of admissions on the pass list which was lowered to 11. Will communicate with managers to match the same at Districts.
    - Girls Cross Country D3 South we lost several teams over the past week. Down to 18 total teams running. Adjusted this race to one (1) race from two (2), with one (1) champion. Qualifiers did not change
  - Fall Tournament Managers & Locations reviewed the updated list of tournament managers and host locations. Noted that Windy Knoll may be sold again. Will review with Golf managers following the season.
