A wrestler may check their weight between 1:00 & 2:00 P.M.  
The Trent Arena is deemed the weigh-in area.
- Pairings:** Final Pairing will be addressed at 3:00 P.M. on Friday.
- Skin Checks:** Saturday morning – Mandatory Skin Check – 8:45 A.M.

- Facilities:** Limited locker space is available. Bring a lock.

- Awards:** Team trophies will be presented to the Champion and Runner-up teams.  
District medals will be awarded to the top six placers in each weight class.  
Recipients must be in school issue uniform; no jeans or hats.
- State Qualifiers:** Four wrestlers from each weight class and an alternate will qualify for the  
State Tournament to be held: Friday – Sunday; March 10<sup>th</sup> – 12<sup>th</sup>.
- Trainer:** An assigned on-site trainer and doctor will be available.
- Team Food:** Teams will be able to have one food table in the upper level of the arena in  
the corners only. **No table or electric will be provided. NO crockpots!!**
- Passes:** Personnel over what the SWDAB covers will have to pay admission.
- Alternates:** Alternates must purchase a ticket. If they wrestle, a refund will be issued.

**Concessions:** There will be full concessions for wrestling fans; **NO** outside food for spectators will be permitted. **Concessions are CASHLESS!!!**

**Floor Passes:** Floor passes / Coaches' passes will not be issued again this year. It is your responsibility to remove yourself from the wrestling area after your wrestler has completed their match. Be respectful of others and return to the stands with your team. Two coaches will be permitted to accompany the wrestler mat side.

**Parking:** Parking will be limited at the time of weigh-ins. There will be parking blocked off specifically for school vans in front of the Athletic Center. Buses will have to park in the front of Fairmont High School. There will be available parking at Christ United Methodist Church on the East side of Shroyer Road and on Lincoln Park Boulevard. School dismisses at 3:00. There should be ample parking by 3:15 on Friday. This is the only session where there may be a problem.

**Hospitality:** The Kettering Fairmont Wrestling Parents will be providing some food and refreshments for coaches. **Be respectful of their work.**

**Statisticians:** **Stats are not allowed in the wrestling area. They shall keep score from their seats, not at mat side.**

**Pics/Video:** **NO** pictures / video from the arena floor without media credentials.

**Transportation:** Bus Drivers will need proper identification for entry to the Trent.

**Professionalism:** The wearing of jeans, t-shirts, sweat suits and warm-up suits (top or bottom), head wear and similar apparel are not considered suitable attire for coaches during the OHSAA Sectional, District or State Wrestling Tournaments and, therefore, are prohibited. Coaches who are inappropriately dressed will not be allowed on the competition floor.
