OHSAA Student Eligibility Appeals Process for 2022-23 School Year

UPDATED: June 12, 2022 – On occasion, school administrators, officials, coaches, parents and/or students form the opinion that a decision of the Executive Director's Office was in error and, as a result, a desire to appeal that decision arises. The Constitution of the member schools of the OHSAA anticipates this and in May 2012, the member schools authorized the Board of Directors to establish an Appeals Panel with exclusive jurisdiction to hear student eligibility appeals. In May 2017 the member schools further modified this process by authorizing the expansion of the Appeals Panel's jurisdiction to hear <u>ALL</u> appeals related to rulings emanating from the Executive Director's Office. At its June 2022 meeting, the Board of Directors reauthorized the Appeals Panel process for the 2022-23 school year.

The Appeals Panel is not completely independent of the Board of Directors and/or the Executive Director's Office, and all members of the Appeals Panel either are or were professional educators from OHSAA member schools. Like the Board of Directors, the Appeals Panel has no authority to waive or modify the requirements of the Bylaws.

In the event that an appeal is requested by an OHSAA registered official, the offending official must notify the Executive Director's Office in a timely manner, preferably at least 48 hours prior to a scheduled hearing, of your desire to appeal.

In the event that an appeal is requested by a student and his/her family, please note that the procedures require that a <u>school administrator</u> notify the Executive Director's Office in a timely manner, preferably at least 48 hours prior to a scheduled hearing, of the desire to appeal a ruling that either the school or the Executive Director's Office has made. However, it is not necessary that the school/school official support or endorse a student eligibility appeal. Furthermore, unless compelled to attend pursuant to the authority vested in the Executive Director's Office, the school official is not obligated to participate in the appeals hearing unless he/she so desires.
