INSTRUCTIONS FOR REQUESTING A CHANGE IN DIVISIONAL PLACEMENT – 2025-26

2-1-1 By entering into an OHSAA sponsored tournament, schools, on behalf of their teams and individuals, agree to compete at the sites, dates and times assigned to them by the OHSAA. Schools that enter into an OHSAA sponsored tournament shall compete in only the division to which they have been assigned for the applicable sport.

Note: In team sports, schools are permitted to enter only one team in OHSAA-sponsored tournaments. In individual sports, schools are only permitted to enter the maximum number of individuals in OHSAA-sponsored tournaments as prescribed in the respective sports' playing rules and/or tournament regulations.

EXCEPTION: Schools may request an alternative divisional assignment to participate in the highest division of a respective sport on a sport-by-sport basis. Such a request must be submitted to the Executive Director's Office by the deadline to be published on the OHSAA website on an annual basis. Requests to participate in any division other than the highest division shall NOT be considered.

SCHOOL ADMINISTRATORS: This form is to be completed no later than **April 18, 2025**, for all sports. Further instructions will be sent for **winter & spring** sports once those preliminary divisions have been finalized. Once completed, please return to the OHSAA office via email attachment, **Attn: Mr. Ronald Sayers** (rsayers@ohsaa.org). All requests received by the appropriate deadline will be reviewed in accordance with the OHSAA Board of Directors approved business rules. Requests received after the date listed above will not be considered. Notification of a decision will be relayed no later than 2 weeks after review by the OHSAA Board of Directors.
