## INSTRUCTIONS FOR COMPLETING BYLAW 4-8-1 EXCEPTION 3 F-1 VISA STUDENT REQUEST- 2026-27

In the summer of 2017, Ohio's General Assembly created a provision to permit international students, who are being housed on the campus of a member school that has boarded students prior to 2014 and continues to provide housing on campus, to have an athletic participation opportunity provided they are here on an F1 visa and meet all other eligibility standards. On July 17, 2019, the Governor signed into law a provision further extending participation opportunities for these students which allows those international students here on an F1 visa to participate at any Ohio member school. Exception 3 to Bylaw 4-8-1 documents this new law.

The purpose of this form is to ensure that international students on an F-1 Visa are compliant with all aspects of Bylaw 4. It is the expectation of the OHSAA that all students covered by this bylaw exception be vetted by a thorough review of the international student's academic records and educational history. **No** student, who would be considered a "graduate" in his or her home country, will be permitted to participate in interscholastic athletics at a member school pursuant to Bylaw 4-3-7. In addition, the OHSAA will review how the student has come to the United States and been enrolled in the member school in terms of the recruiting section, Bylaw 4-9. To that end, we will require the submission of the student's properly completed I-20 form. Send completed form and student's completed I-20 to Lizzy Wilson (lwilson@ohsaa.org).
