## INSTRUCTIONS FOR COMPLETING BYLAW 4-8-1 EXCEPTION 1 J-1 VISA STUDENT REQUEST- 2025-26

Exception 1 to Bylaw 4-8-1 permits students who possess a **J-1 Visa** issued by the Federal Government's Visitor's Exchange Program to be eligible for athletics for a maximum of one school year (two semesters) provided they meet the scholarship requirement and have not graduated from their home school or attended **high school** more than eight semesters.

It is the expectation of the OHSAA that all request for eligibility for international exchange students preceded by a thorough review of the international exchange student's academic records and educational history. **No** student who would be considered a "graduate" in his or her home country will be permitted to participate in interscholastic athletics at a member school pursuant to Bylaw 4-3-7. Please be advised that students in South America may have graduated at the end of their 11<sup>th</sup> grade year. The OHSAA will only grant eligibility, under exception 1, to those students who possess a J-1 Visa. Please review Bylaw 4-8-1 for additional exceptions for International Students.
