- 2 - Select the orange "Official" icon
- 3 - On the left-side menu toward the bottom select the button labeled "Special Presentations" under the orange section header labeled "OHSAA Resources"
- 4 - Once on the Special Presentations screen, select the meeting for your sport by selecting the "View" button for your sport's meeting.
- 5 - After the "Last Date Available" listed above, the meeting will not be available for viewing or local meeting credit.

If you watch the wrong sport's meeting you will not receive local meeting credit.
