#### Abstract

Clip 1 - initial altercation, gray player coming off the bench, head coach/assistant coaches entering the court (note: why do we allow grey coach, but emphatically point by two officials the white coaches back to the bench? Is this a good look?), who is the spectator that enters the court (it happens to be AD). Would this be construed to be a fight (4 game suspension)? NO, this does not rise to level of a fight!

## FALSE DOUBLE FOUL

4.19.9 (C): A1 has a breakaway lay-up. B1 commits a hard foul against A1 from behind and its ruled an intentional foul. The Team A head coach protests, feeling the fouls should have been a flagrant foul and is assessed a technical foul.
A. Award A1's goal if successful. Team B is awarded two free throws for the technical foul with the lane spaces cleared. Then A1 shall receive two free throws for the foul committed against him/her. Team B is awarded the ball for a throw-in at the division line opposite the scorers table.
B. Award A1's goal if successful. Team B is awarded two free throws for the technical foul with the lane spaces cleared. Then A1 shall receive two free throws for the foul committed against him/her. Resume play with the out-come of the free throws.
C. Award A1's goal if successful. A1 shall receive two free throws with the lane spaces clear. Any Team B player is then awarded two free throws for the technical foul. Team A is awarded the ball for a throw-in at the point of interruption
D. Award A1's goal if successful. A1 shall receive two free throws with the lane spaces clear. Any Team B player is then awarded two free throws for the technical foul. Team B is awarded the ball for a throw-in at the division line opposite the scorers table.
