# **2023 OHSAA Cross Country Officials Manual**

The 2023 OHSAA Cross Country Officials Manual is now available by clicking <u>HERE</u>. Please make sure you review this document as you would the NFHS Rule Book and have the manual available in either paper or electronic form when officiating. If you have a smartphone, you can bookmark the link or save the document to your files/cloud.

### The Proper Cross Country Start Procedure

There has been some confusion related to the use of the "Walk Up Start" as it is being referred to. The correct starting procedures are outlined in NFHS Rule 8-4-4 and on NFHS Officials Manual Page 42. In the tournaments, we follow the audio/visual starting process in Ohio for tournaments, and it is STRONGLY recommended that this process be followed at all regular season meets for consistency.

This process will be reviewed on slides 8-12 of the virtual local meeting that will be available to officials soon.

#### 2023 – 2024 Officials Handbook Updates

Each year, the OHSAA makes adjustments to the Officials Handbook. This handbook is the go-to for non-competitive officiating questions. It can be found by clicking <u>HERE</u> and then clicking on "Officials Handbook." Highlights of the changes are outlined below. Please review the full document linked above for full details.

### **Tournament Pay Increase**

For the third year in a row, officials will see an increase in tournament pay. In 2021 and 2022, officials saw increases in pay for track regional tournaments. In 2021, the increase brought track regional pay in line with districts. In 2022, track regional pay moved to \$10 more than the district. Effective with Cross Country this fall, each level of the tournament will see a \$10 increase per official per day\*. While \$10 does not seem like a lot per person, this raise accounts for a \$30,000 investment into tournament officials' pay per year. In 2022, investments totaled approximately \$23,000 and included: 1) Pay raises for regional track 2) Additional officiating positions added at the regional and state level of both sports, the 7<sup>th</sup> & 8<sup>th</sup> Grade Cross Country Invitational and 7<sup>th</sup> & 8<sup>th</sup> Grade Track Championship 3) The OHSAA adoption of the summer officials clinic 4) The addition of hotel rooms at the state meet. In 2021, we saw a \$5,000 investment with the increase of track regional officials' pay. Since 2021 we have seen nearly \$60,000 in investments into officials in our sports.

\*District cross country pay is set at \$130 per meet. This rate is based on the standard district that has six races. Districts that hold more than six races will see different pay for their day based on the number of races held.

#### **Official Uniforms**



Officials' shirts now need to be tucked in unless the shirt has been manufactured not to be tucked in (i.e. women's cut shirts) or there is a medical reason why it cannot be tucked in.

People have reached out and asked about suspenders. They are not covered in the uniform rules and are looked at no differently than a belt; if you need them, wear them. Also, for clarification, if a hat is worn, it MUST meet the guidelines as outlined in the policy.

## **Years of Service Needed for Tournament Assignments**

The number of years need to be eligible for tournaments has been changed to reflect the reality of our current officiating numbers. Years of service for districts have been reduced to help fill the needs at that level, while the years of service for the state meets have been increased to reflect the higher level of skills needed in those positions. The new years of service are listed below:

District – 1 (one) year (previously two)

Regional – 4 (four) years (no change)

State – 8 (eight) years (previously six)

# **Required Meeting Attendance for New Officials**

New officials will now be required to attend the state rule meeting and one local meeting in the year they take their test. Previously, the only educational requirement that was needed for a first-year official was the test. This change, in addition to new online course structure, will help ensure our new officials have a better foundation as they start their career.

### State Rules Meeting.

The deadline to complete the meeting requirement without paying the \$50 penalty fee is below. **If you are a coach and an official you MUST take both state rules meetings.** While the content is similar there is information in the coaches meeting not contained in the officials meeting and vice versa. This was instituted in 2021 for our sports and brought us in line with all other sports.

#### Save The Date 2024 OT&F&CCOA Clinic & Awards Dinner

## **Changes to New Officials Testing & Class Process**

Effective in June, we have implemented a new process for the education and testing of new/prospective officials. Please see below for details of the new process.

- The new course went live in June, with a new one available monthly for prospective officials. This will allow us to continue to recruit new officials year-round.
- The course will ONLY be available online, and we will no longer be able to host inperson new officials classes. This brings a high level of consistency to our education process.
- The new process will provide the new officials with 7.5-8 hours of self-paced officiating education between two separate courses managed through one central process. The steps are below:
  - Create an account on MyOHSAA; access this through the OHSAA officiating page.
  - Pay the required fee.
  - Receive the rule book electronically.
  - Take the RefPrep course & upload the completion. Course includes narrated content and multiple guizzes.
  - Take the NFHS Officiating Track course & upload the completion.

- Take the concussion course & upload your certification number. I recommend they take the NFHS certification as they will have already created a free NFHS account through the previous step.
- Take and pass the test.
- Be connected with their local officials' association.
- In conjunction with RefPrep, I will make changes to their course yearly. The NFHS will make adjustments to their class as appropriate.
- Mariah Hohman has been selected as the instructor for our new virtual class offering; she will
  handle all new officials for our sport in the state. Once new officials start the process, she will
  ensure they progress through the process by completing each step, and at the end, she will make a
  direct connection of the new officials to me as well as their local association. Prospective officials

- Jeff Polhemus will continue to lead the recruitment, retention, and mentorship committee that was formed for our sport last year.

I am excited about this educational and testing process and its support for prospective officials. Our new officials will be better prepared when they step on the track, and for the first time, we will have a process that directly connects them to their local association secretary. We know that connection to local associations, especially the mentorship and socialization they provide, is critical to retaining new officials.

I ask that each association work to connect each new official with one of your veteran officials who can provide them with mentorship through their first few years. Our veteran officials have a wealth of knowledge and expertise they can (and should) share with our new officials.

I also want to dispel a rumor that is going around. Current officials will <u>NOT</u> be asked to take this course; this process is for new officials or officials who have had a lapse in their license.
