Now that the holidays have passed, many will begin officiating indoor track and field, while others will wait for what is hopefully a dry, sunny and warm spring season. As we have done for many years, the pre-season is a time for us to attend local rules meetings, view a state interpretation and focus on continuing education. This bulletin includes information on some new resources and opportunities as well as updates on things we have done for many years. Important Note from the OT&F&CCOA about the January Clinic

The executive committee of the OT&F&CCOA has been monitoring the latest information related to the COVID surge and is planning to move forward with the clinic as scheduled. 4x800 M Relay Added For Middle School Track

The OHSAA board today (January 13) voted to add the 4x800 meter relay to the middle school order of events. It will be placed into the order to mirror high school as the first event. The recommendation to add the 4x800 to middle school was brought to the Track Advisory Committee last year for consideration and was supported by that group. Adding the 4x800 meter relay will now provide a third distance event for middle school athletes and help balance the number of sprint and distance events offered. The Track Advisory Committee consists of the DOD, Sport Administrator, elected officers from the coaches and officials association, and at large members from the coaching and officiating bodies.

One Rule – One Interpretation

Consistency in the application of rules is, and always has been, of the most importance in how we approach continuing education. We are adding additional opportunities and resources for officials with that in mind. My goal is that all associations and over 800 individual officials enforce rules consistently using the same interpretations; One Rule – One Interpretation. In addition to the items listed below, we will be much more purposeful in regularly sending out communication to all officials. Throughout the year-- specifically during the season-- I will be sending out communications like the end-of-season cross country note everyone received in the fall. These will be based on the most asked questions to the state interpreters and also include information about any issues that have come up.

Local Rules Meetings

I encourage you to participate in as many local rules meetings as possible, not just your required amount. I ask that we all focus on continued education, not simply meeting the requirement. Manual for Coaches & Officials

There is now a formal evaluation document that evaluators will complete and a FAQ document that will give everyone more information and clarity around the process. While this educational tool does not review Ohio-specific modifications, it is a fantastic educational tool available to all of us. To view this training, please visit the below link. If you have participated in the NFHS Concussion Training, you will use the same log-in information you set up for that. If you do not have an NFHS account, you will need to set up a free account before moving forward with this training. Once you have set up an account, you can "order" the free track and field officiating training and then view it at your leisure.
