Cross Country Assignments

Congratulations to the officials assigned to the OHSAA Early Season Invitational, 7th & 8th Grade Postseason Invitational, Key Regional Tournament Positions, and State Championships. The assignments were made in accordance with the approved assignment processes and procedures, which can be found by clicking <u>HERE</u>.

Not Enforcing Rules

I continue to have issues reported weekly that are occurring because of inconsistent enforcement of the rules. The issues arise when an official enforces the rules correctly and they have not been week(s) prior. As I have stated numerous times, the best thing we can do for our student-athletes is consistent application of the rules.

As we move into the tournaments and conference week, I am asking that we all work together to ensure consistency in the application of the rules so athletes and coaches are not caught off guard when the rules are applied properly at the tournament.

Reminder on Team Uniforms

Per NFHS Rule 4-3-2 all relay and cross country team members must wear uniforms clearly indicating through predominant color, school logo and color combination of all outer garments worn as a uniform that members are from the same team; this rule applies even when a team has less than a full team in regards to scoring. **Regardless of how many athletes a team has, they all must comply with 4-3-2.** This rule applies to the regular season and post-season alike.

The only time a school would be allowed to have different uniform combinations would be when the school has split their team with the permission of the meet manager. For example, the competitors in the team race do not need to match the team in the open race. Another example would be when the school has been allowed to enter two teams in one race (i.e., A & B) teams. These separate teams would be in separate boxes, listed on the paperwork as two teams, etc.

At the regional and state meets, even when athletes have qualified as "individuals" and are not able to receive a team score, they all **must have matching school-issued uniforms** as they are competing for the same team.

Medical Device Paperwork

For clarification, ANY paperwork that states a medical device is needed and has been completed by a physician or physician's office is acceptable, including physical forms. We had an issue with a physical form earlier this season, and I had originally given the wrong guidance. I apologize for any confusion that error caused.

Officials Role in Eligibility

Officials are responsible for the enforcement of contest rules as outlined in the NFHS Rule Book, Officials Manual, Sport Regulations and Tournament Regulations. Officials are NOT responsible for, nor do they have a role to play in ANY eligibility related items including gender, age, grade, etc. If officials suspect, there is an



eligibility issue, they can report that to me AFTER the meet takes place and I will ensure the appropriate staff in our office are made aware. The same applies to contracted FAT providers; contractors should not be involved in making any eligibility decisions.

If coaches approach you with eligibility related questions, please refer them to our office and we can address the issue/question with them after the meet. Student-athletes should never be prohibited from participating in a meet due to a suspected eligibility issue by an official, contractor, or coach. The rule of thumb is that if they are on a roster/entered in the meet, they compete, and our office will sort out any issues after the fact.

I understand that language in the Officials Manual has created some confusion. That same language has been in the manual for over 10 years as Dale and myself felt it important it be there for our officials who also function as meet managers. However, that information will be clarified in the 2025 manual.

2024 Cross Country Tournament Regulations & Information

They include several new regulations intended to bring consistency across all of our sites and provide our student-athletes with predictable and consistent competition. The NFHS National Rules Committee for our sport consists of representatives from the eight NFHS sections, a coach's representative, an official's representative, and a chairperson. The committee makes recommendations that are then sent to the NFHS board for final approval.

Officials should continue to work through the Ohio Track & Field and Cross Country Officials Association for any rule change proposals. Those reaching out directly with rule/policy change requests will be directed back to the state officials' association.
