Here are a couple of questions I received this week:

- 1. **HEAT, HEAT:** It is up to each school district concerning altering games or practices because of heat. OHSAA recommended guidelines are in our Handbook and in the Football Regulations. Both can be accessed on our website.
- 2. Lots of questions on equipment including visors, Guardian Caps and Player Equipment. See below for specific information.

## Rules

- 1. Visors: NFHS Rule 1-5-3c4 states that visors must be clear and that tinted eyewear (glasses) may be worn under the clear visor. A prescription from a Dr. does not supersede this rule. Any accommodation outside of NFHS Rules (NFHS Rule 1, Section 8) for an athlete in football must be approved by the OHSAA office (Beau Rugg). The accommodation is only granted if the rule does not resolve the player's condition. Have your Athletic Director contact me.
