- Lack of elements that achieve or pass thru vertical Up to 0.20
- Uncharacteristic Element 0.10 each
- ¾ front giant (w or w/o grip change) 0.10 each
- Choice of Elements- Failure to perform 2 of 3 Up to 0.20
 (Must have 2 of 3 for no deduction- 0.10 if routine only has 1 and 0.20 if none of the requirements are met) All skills must be a minimum of B value part.
 - 1. Flight Skill
 - 2. Pirouette
 - 3. 3/6/7 Skill

- Lack of Dance Series 0.20
- Failure to perform 2 acro skills in a row <u>0.30</u>
- Choice of Acro Elements Up to 0.20
