# COVID-19, OHSAA AND GOVERNOR'S ORDERS

### **ODH ORDER UPDATE**

On September 25, the Ohio Department of Health amended the requirements for youth, collegiate, amateur, club and professional sports so that schools can participate against more than one other school in a 24-hour period. This is good news as it does open up the ability for schools to host and participate in tournaments with a format calling for multiple games in one day. Please note that no other sections of the order were adjusted. This means all requirements for coaches, participants and spectators are still in place. ## ICE HOCKEY NON-INTERSCHOLASTIC DATE

At the October 1 OHSAA Board of Directors Meeting, a proposal to adjust the non-interscholastic date from the start of the season to December 30 was approved by our Board. As a reminder, the non-interscholastic date is the date at which students must cease competition with a club/travel/pre-post team and join their school team in order to be eligible for the OHSAA tournament. The date of December 30 falls in line with the USA Ice Hockey deadline for those USA Ice Hockey teams to set their rosters. This date will remain December 30 for the foreseeable future.

A big thank you goes out to the Ice Hockey Advisory Committee for their feedback on insight into this matter! This is precisely why the advisory committee exists.

## **REMINDERS**

I've received several questions multiple times over the past week, so I'd like to use this opportunity to address those. If you have any additional questions, please do not hesitate to reach out!

- The first day teams are permitted to practice is October 30
  - This means the four acclimation days begin on October 30, with the final acclimation day being November 2; schools **are not permitted** to complete the four acclimation days prior to October 30
- Scrimmages/Previews may begin on November 3
  - If you'll be competing against a Special Olympics or similar team, please be sure to fill out the contest waiver and submit to me prior to the contest taking place (<u>https://ohsaaweb.blob.core.windows.net/files/Sports/Ice-Hockey/2020-</u> 21/SpecialOlympicsWaiver20 21.pdf)
- The Rules Interpretation Meeting will be available for you to view on October 14 through myOHSAA
  - o If you do not remember your login, please let me know and I will get a reset password email out to you pretty quickly
