5 - Member of a School Team

For OHSAA purposes, a member of a school team is defined as any student who has played in a scrimmage, preview, regular season contest, or tournament contest as either a starter or substitute. In short, a player has joined their school team after they have participated in a scrimmage or contest. Simply participating in practice does not constitute a player as having joined their OHSAA school team, for OHSAA purposes.

This distinction is important for the enforcement of non-interscholastic participation (girls lacrosse regulation 2). Once a player has joined their school team, they may not compete in any non-interscholastic scrimmages, previews, or contest.

Please educate your team and parents, and if you have any questions about your players' participation in any activity outside of your team during the season, please email me in advance to review the situation.
