2 - Online State Meeting Dates

The online state rules meeting will be available through myOHSAA on Tuesday, February 8 at 9 AM. All coaches will be emailed directly when the meeting is available. The meeting will be available until Friday, March 18. After March 18, a \$50 late fee will apply until Monday, May 2 at 11:59 pm. After May 2 there will no opportunity to complete the required meeting.

The 2022 Girls Lacrosse Coaches Manual will be available prior to the state meeting going live on February 8.

3 - Review of Significant Changes to 2022 Regulations

The most significant change made to the girls lacrosse regulations was 1.3, see except below:

Penalty for participation in more than three (3) halves per day: The penalty for exceeding the participation limitation during a contest is forfeiture of the contest in which the ineligible player is participating. When discovered, the ineligible player is removed from the contest, and the contest

may continue to completion; however, the result of the contest shall be a forfeiture by the offending team.

This type of change was made in all team sports when an individual is discovered having exceeded their daily participation limitation. Please be aware of this change and track your players' daily quarter limitations diligently.

5 - Review of OHSAA Bylaw 9-2-1: Travel to Non-Bordering State

Per the spring 2021 referendum voting, schools are now required to request permission from the OHSAA prior to traveling to a non-bordering state for competition (Bylaw 9-2-1) for the current 21-22 school year.

Full text of revised bylaw is below:

9-2-1: Schools may travel out of state to compete in contests in states or provinces in Canada that border Ohio regardless of distance to travel. The states are Indiana, Kentucky, Michigan, Pennsylvania and West Virginia. The province is Ontario. Additionally, schools may travel out of state one time per sport per interscholastic season to compete in contests in any location that does not border Ohio subject to approval from the Executive Director's Office. (Visit ohsaa.org to obtain the required form to request this travel permission).

Penalty for violation: A school which travels to a non-boarding location to compete in contests on more than one occasion shall be ineligible for the OHSAA postseason tournament in the sport in which the out-of-state travel was involved and could be subject to additional penalties as referenced in Bylaw 11. A school which travels to a non-boarding location without approval from the Executive Director's Office shall be subject to a fine and could be subject to additional penalties as referenced in Bylaw 11.

6 - Review of Out-of-Season Regulations

8.3) Individual Skill/Coaching Instruction – Team Sports of Baseball, Basketball, Field Hockey, Football, Ice Hockey, Lacrosse, Soccer, Softball and Volleyball

8.3.1 - From August 1 through May 31 From School Coaches – In the sports of basketball, field hockey, ice hockey, lacrosse, soccer and volleyball, individual skill/coaching instruction may be received by a member of a school team or individuals at any time prior to and after the school season and outside the defined no-contact periods (see General Sports Regulation 11) from school coaches provided that no more than four members of a school team or individuals are present at one time in all facilities where the individual skill/coaching instruction is taking place.
