## **Ticketing Information**

The OHSAA State Swimming and Diving Tournament tickets will be conducted online through HomeTown Ticketing. <u>There will be no tickets sold at the gate.</u> This information can be found on the OHSAA Swimming and Diving Tournament page <u>here</u>.

No tents or other enclosures will be permitted on the property of the Canton City School District. Tickets are not numbered, therefore, spectators may only begin lining up one hour prior to the doors opening for the event. There is absolutely no alcohol or other drugs permitted on the property.

<u>Venue policy regarding Covid-19:</u> Masks are required to be worn at all times regardless of vaccination status. This requirement has been set forth by the C.T. Branin Natatorium. OHSAA events must adhere to the current COVID-19 policies at the host tournament venues.

## **Ticket Purchasing Procedures:**

**Division I and II State Diving Sessions:** General admission tickets will be available online for purchase beginning **Monday February 21 at 10:00AM**. Specified ticket allotments will not be distributed to qualifiers and coaches for pre-purchase. Those planning to attend diving sessions are directed to purchase tickets online through the OHSAA website on a first come first serve basis until the sessions are sold out.

**Division I and II Swimming State Qualifiers and Coaches – PRELIMS:** Qualifiers and coaches shall receive a specific number of tickets in advance to purchase. Ticket allotments shall be determined by the number of qualifiers.

Athletic Directors shall receive these codes via email on **Sunday February 20**<sup>th</sup> and will be responsible for distributing ticket purchasing codes to each coach and qualifier. Those with codes may purchase tickets beginning **Monday February 21**<sup>st</sup> at **10:00AM** and will have up until a specific deadline to purchase tickets before they are released for public purchase. Deadlines will be included with the advanced purchase information.

**Division I and II Swimming State Qualifiers and Coaches – FINALS:** Finalists and coaches qualifying for the final rounds of the State Tournament shall shall receive a specific number of tickets in advance to purchase. Ticket allotments shall be determined by the number of qualifiers. Athletic Directors shall receive these codes via email soon after all the qualifiers are determined and will be responsible for distributing ticket purchasing codes to each coach and qualifier.

Once the tickets are distributed, qualifiers and coaches will have up until a specific deadline to purchase tickets before they are released for public purchase. Deadlines will be included with the advanced purchase information. Please note, due to the schedule of events, this will be a quick turnaround. The codes provided for the finals will be different than those provided to the preliminary rounds.

**State Relay Alternate(s):** Per the OHSAA Tournament Regulations, coaches must pay \$20.00 for a relay alternate to attend the State Tournament. <u>Alternate passes must be purchased on site</u> with credit card only. Cash or checks will not be accepted.

**College Scouts:** A small allotment of tickets will be available for college scouts with a valid ID to purchase on site the day of the event. Tickets are based on availability and will be on a first come first serve basis. Those wishing to purchase tickets must enter through Door N1.
