## **OHSAA SWIMMING AND DIVING GENERAL INFORMATION**

### Important Future Dates

Oct. 12, 2022	State Rules Meeting will be available
Oct. 28, 2022	First Day of Coaching
Jan. 23, 2023	Non-Interscholastic Date

### Diving

For the sport of diving, other than a championship meet, the competition shall consist of one voluntary dive, which shall be done in a specified order (NFHS Rule 9-4-6). The rotation schedule can be found on the OHSAA website [HERE](#).

Additionally, per the OHSAA Tournament regulations, divers entered in the OHSAA Tournament must have competed in an 11-dive championship competition at least once during the regular season. Entry into the tournament confirms that the diver can perform an 11-dive championship slate.

### HyTek Codes

When inputting your team information into the HyTek system for meets and the OHSAA Tournament, please be sure to use the specified HyTek code assigned to your school. These can be found on the OHSAA website [HERE](#).

### Ohio High School Swim Coaches Association Update

The Ohio High School Swim Coaches Association (OHSSCA) serves as a consulting group to the OHSAA regarding swimming and diving. Over the past few years, the OHSSCA has worked with OHSAA to implement key improvements like para events at the state meet, earlier season start (October), 15 minute rule between events and others. We are currently working with OHSAA on several items, including additional revisions to the state tournament process. Membership with the OHSSCA is voluntary, but broader participation from all coaches helps strengthen our voice with OHSAA. ## SPORT REGULATIONS

---

GSR 20.2 – Head Decorations/Headwear/Religious Apparel (**Waiver no longer needed**)

Regardless of NFHS Playing rules, Ohio state law requires that officials/contest administrators not prohibit, require a waiver, or create any obstruction to wearing religious apparel when competing or participating in interscholastic athletics or extracurricular activities, unless a legitimate danger to participants is identified due to wearing religious apparel. If such a danger is identified, the administrator or official of the event or activity shall offer all reasonable accommodations to the participant wearing religious apparel.

### Swimming and Diving Sport Regulations - REVISION

The current Swimming and Diving Sport Regulations posted on the OHSAA website contains a typo referencing a minimum participation in two contests prior to the OHSAA Tournament. This is specific to relays referenced in 1.3.

#### 1) Interscholastic Participation

To be eligible for the the OHSAA tournament in swimming and diving, student-athletes must become a member of the school team prior to the non-interscholastic date, at least four weeks (28 days) prior to the Monday of the week of the state tournament. ~~and compete in a minimum of two interscholastic contests prior to the OHSAA Tournament~~

#### 1.3) Relay Entry

In order to be eligible for relay event entry in the OHSAA-sponsored tournaments, a school shall compete in a minimum of two interscholastic contests as a school team prior to the non-interscholastic cutoff date.
