THIS WEEK IN VOLLEYBALL

End of Season Issue I November 11, 2020

MANDATORY NO CONTACT PERIOD - General Sport Regulation 11

This is a reminder that the No Contact Period for volleyball begins with the first day after the last interscholastic contest and **ends 28 days later**. Coaches, whether paid or volunteer, are *prohibited* from providing coaching and/or instruction, instructing conditioning and physical fitness programs or open gyms, with members of its school team. If your school coach is also a non-school (club, travel, etc.) coach, it includes any type of non-school participation as well.

FAQS

Q: Can I host an end of season banquet during the No Contact Period?

A: Yes, as mentioned in GSR 11 Exceptions, there are certain activities that may take place during the No Contact Period, as long as there is no type of instruction provided.

Q: I am the junior high (grades 7 & 8) coach and my season ended a few weeks ago. However, our high school team is participating in the State Tournament. Do I have to wait for them to complete their season for my 28 day No Contact Period to being?

A: No, since you are the junior high coach, the No Contact Period begins with the first day of the last junior high contest and *not* the last high school contest.

Any coach who may violate the mandatory No Contact Period may be prohibited for one calendar year from out-ofschool season contact with athletes from their school where employed or subject to penalty as specified in Bylaw 11.

PLAYING/COACHING OUTSIDE OF THE SEASON

PLAYERS

Please make sure to remind your players that they may compete in non-interscholastic activities as soon as their school season is complete. Once their season has ended, please make them aware that there may only be 3 from the same school team participating together with a non-interscholastic program. The only exceptions to the 3-player limitation are if they were not a member of the 2020 school-sponsored volleyball team or if they are a graduating senior. There can be NO rotating players on the non-interscholastic program(s)—for example, you cannot have 3 players for one club tournament and another 3 players for another club tournament the following weekend. There may only be 3 players from the same school for the entire non-interscholastic season.

COACHES

Coaches are permitted to coach non-interscholastic teams outside of the season. Coaches are also permitted to coach their *own* school-team players on non-interscholastic teams outside of the season, as long as the 50% limitation is followed—there shall be 3, or less, members of their school team on the non-interscholastic team. As previously mentioned, there cannot be rotating players from the same school on a non-interscholastic team. If a school coach coaches their own members on a non-interscholastic team outside of the season, the No Contact Period is still in effect.

Congratulations to those teams that are participating in the State Tournament! The 2020 State Volleyball Tournament is taking place at the Butler High School Student Activity Center in Vandalia this weekend, Friday, November 13 – Sunday, November 15. This is a reminder that the tickets are not available for the general public and are for the participating schools only. We look forward to welcoming volleyball coaches back to our great State Tournament in the future!
