1 - Girls Wrestling Tournament Update

If you did not receive the email from me and believe your school is going to have girls entered in the girls wresting tournament, please check with your AD to ensure your school is marked as offering "girls wrestling" and is appropriately entered into the tournament.

3 - GIRLS HEAD COACHES: Reviewing Girl Wrestler Assessments and Profiles

All head coaches of girl wrestlers should have a separate login for the "girls season" in Trackwrestling. Many coaches were not listed as the head coach for girls wrestling in myOHSAA by their AD on the date that I had to pull the information for Trackwrestling to create profiles. If you do not believe you have your profile for the girls wrestling season in Trackwrestling, please email me.

Please login to your profile in the girls season of Trackwrestling to ensure all of your girl wrestlers' assessments are present and valid. If not, please email me the names of the wrestlers so that I can look into it.

You may recall, all girls that were assessed prior to 11/24 were copied over to the girls season on 11/25. After 11/25, assessors were to enter any remaining female assessments directly into the girls season.

4 – BOYS HEAD COACHES: Marking Girls Inactive in the Boys Season in Trackwrestling

If you do not want to see your girl wrestlers in the boys season of Trackwrestling any longer, coaches can submit a <u>help ticket here</u> to request those girls be marked ineligible in the boys season and Trackwrestling's Customer Support team can execute that request for them.
